➔ Manage Carriers

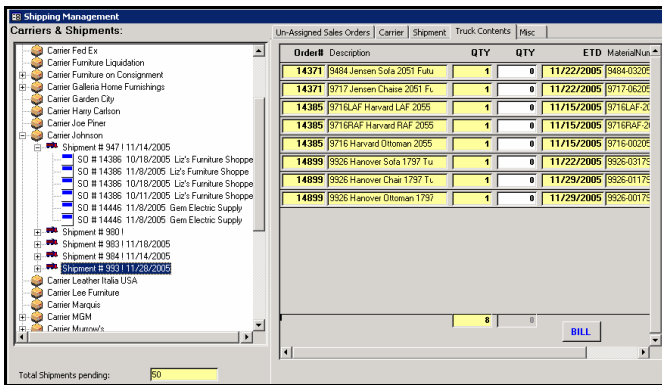
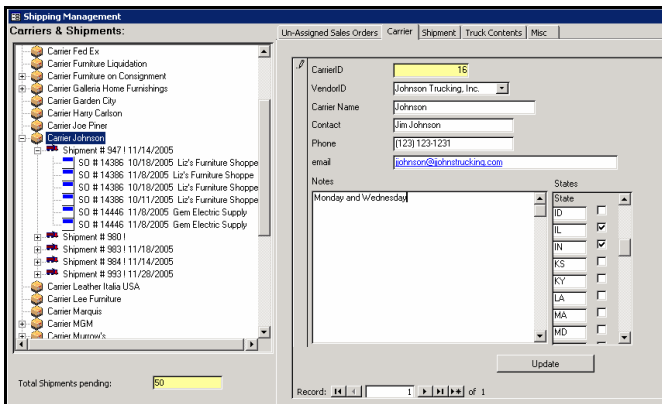
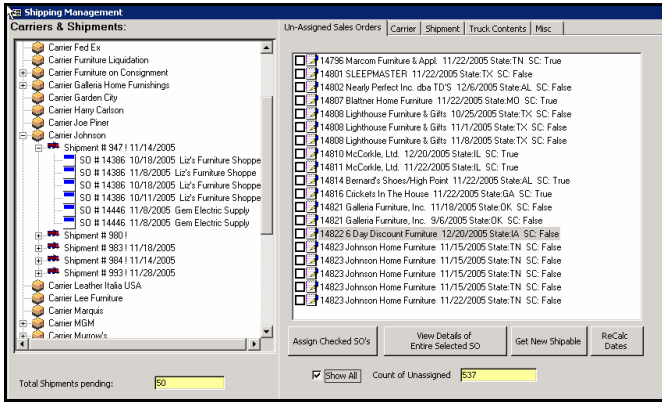
- Add and Maintain Carrier Profile/Contact Info
- Assign territory of operation by state

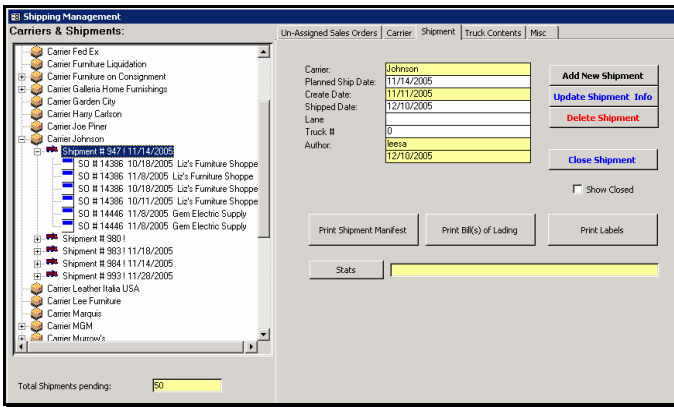
➔ Ship Goods

- Fulfills from default or assign bins
- Short Ship – creates automatic backorder

➔ Additional Tools /Reports

- Check on Order Status – reports truck assignment for all goods on order
- Order Shipping History – reports on all goods shipped this order
- Order Billing Status – reports on goods shipped – billing status
- Truck Schedule by day/week

 - Print Manifest – consolidated pick list
 - Print Bill of Lading – 1 per order/ship address on truck
 - Print Labels – 1 per item to be shipped
